The Manitoba Aviation Scholarships are made available each year by local sponsor organizations individuals continuing their aviation training and education with a Manitoba-based aviation training organization. General Eligibility - All applicants shall be:

- A Manitoba resident willing to undertake training at a Manitoba-based aviation training organization
- Of age to meet any age restrictions to begin training in the current calendar year
 (an at least 40 users and for a private pilot a balanchin)
- (eg, at least 16 years old for a private pilot scholarship)Interested in pursuing a career in aviation
- An active volunteer in the community

- 2. Provide a transcript of your high school marks <u>or</u> recent post secondary marks <u>or</u> flight training assessment
- 3. Provide a letter of acceptance or evidence of current registration from the post-secondary institution / aviation training organization which you are (will be) attending
- 4. Provide two (2) letters of reference in support of your application (may be sent/delivered separately)
